



The Brock Scholarship

Purpose:

Credit Union Advantage has established a scholarship fund to assist two deserving members who are currently high school seniors or high school graduates entering in to a post secondary undergraduate education.

Amount of Scholarship:

Payment of the \$1,000 Scholarship will be made in the form of a check payable directly to the student to be used for college related purposes – tuition, books, supplies, etc.

Eligibility Guidelines:

1. Be a member in good standing at Credit Union Advantage. If under age 18, parent must also be a member at Credit Union Advantage.
2. Between the ages of 16 and 20.
3. Applicant must be a current senior or a graduate of an accredited high school ready to begin or in the process of obtaining a post-secondary undergraduate education at an accredited college, university or vocational school.
4. Submit a copy of the acceptance letter from the college, university or vocational school (must be received before scholarship is distributed, if chosen).
5. Be enrolled as a full-time student (minimum 12 credit hours per semester).
6. Applicant must have a minimum grade point average (GPA) of 2.75 based on a 4.0 grading system. An official copy of transcript for the past year is required.
7. Have a demonstration of service and/or extracurricular activities at school or in the community.
8. United States citizenship or permanent residency.
9. One letter of recommendation from school representative, clergy or civic person.
10. Must be received by **June 30, 2019**.

Winners are chosen by a random drawing from qualified applicants on July 19, 2019.
